1. All should know as much those present as future that I Robert of Maltebi and Sybil my wife did give and did grant and confirm with this our present charter
2. to Robert of Egerton and Constance his wife 6 bovates of land with appurtenances in Thornton in Strata with
3. a certain capital messuage in exchange for 2 Bovates of land in Maltebi and moreover for 30 marks which they gave to us cash in hand
4. to have and to hold to the same Robert and Constance and their heirs or assigns and to the heirs of them from Alan of Bonington and Berta
5. his wife for the whole life of the same Alan and Berta In Fee and inheritance freely quietly and peacefully By rendering annually to the same Alan and
6. Berta his wife while they should live forty shillings of sterling namely at the Ascension of the Lord twenty shillings and at the feast of Saint
7. Martin in Winter twenty shillings and one pound of pepper at the birth of the Lord or twelve pence and one pair of white spurs
8. or three pence for all service custom exaction suit of court and claim And after the decease of the aforesaid Alan and Berta
9. by rendering to their heirs forty shillings at the aforesaid terms and to the chief lords of the fee all other services which pertain to
10. – 12. the aforesaid tenement And I Robert of Maltebi and Sybil my wife and our heirs will guarantee will acquit and in perpetuity will defend all the aforesaid land with the capital messuage with all the aforesaid appurtenances to Robert and Constance and to their heirs or assigns and to the heirs of them against all men In testimony of which matter I Robert of Mal-
13. -tebi have affixed my seal to the present writing with these witnesses with the lord Alan of Wassand the lord Richard his brother the lord Peter
14. of Wassand Alan of Bonington lord William of Thornton Vicar Hugh of Thornton Roger of Leke Robert
15. and Hugh of BraithWath and others.
