1. All should know as much those present as future that we Walter of Buketon and Constance my wife have
2. granted, have given and with this our present script have confirmed to Robert of Elgtona son of the aforesaid Constance and to Agnes
3. wife of the aforesaid Robert daughter of the aforesaid Walter two tofts and seven bovates of land in the town and the territory of Thornton
4. in Strata Those namely that Radulph of Thornton once held from us Holding and having to the aforesaid Rob-
5. -ert and Agnes his wife and the heirs of the body of Robert himself procreated legitimately from us and the heirs
6. of the aforesaid Constance, freely, without trouble, fully, peacefully and acquitted with all their appurtenances and easements without
7. any retention. And if it should happen, may it not be so, that the aforesaid Robert should die by an ill fate before the aforesaid Agnes
8. the whole aforesaid land with the aforesaid tofts with all their appurtenances and easements and escheats should remain to the aforesaid Agnes for
9. her whole life under the heading of dowry freely quietly and acquitted. We truly the aforesaid Walter and Constance
10. and the heirs of the aforesaid Constance will warrant will acquit and will defend against all men all the aforesaid land as was aforesaid to the aforesaid Robert and Agnes his wife.
11. And to their heirs of the body of Robert himself legitimately procreated, or, if it should happen, may it not be so, that the aforesaid Robert should by
12. an ill fate die before the aforesaid Agnes, to the aforesaid Agnes for the whole of her life under the heading of dowry
13. And if it should happen that the aforementioned Robert with the aforesaid Agnes his wife
14. have not procreated heirs of his body, may it not be so, all the aforesaid land with all its appurtenances and escheats after the
15. life of the aforesaid Agnes should wholly revert to us and to the heirs of the aforesaid Constance without the contradiction of anybody
