1. To all who will see or hear this writing William son of John of Thornton in Strata and Isabella daughter of Thomas of Otrige-
2. –tona greeting in the Lord. You should have known us to have given, granted and confirmed by this our present cirograph to John son of Richard
3. of Thorneton in Strata our whole capital messuage in Thornetona in Strata and half of all our land meadow and
4. pasture as lies in our diverse arable lands and in our meadows in the territory of Thornton in Strata ^in the north part^ and our whole meadow in
5. North kylvyngton to be held and to be had to the said John for the whole time of the life of John himself from us and from the heirs of our bodies legitimately
6. procreated freely quietly wholly well and in peace with all their appurtenances liberties and easements pertaining to the said messuage of land and meadow within
7. the town of Thornton in Strata Northkylvington and near and far outside everywhere. By paying thence annually
8. to us and to the heirs of our bodies legitimately procreated sixteen shillings and eight pence of silver at four appointed terms of the year in Alverton-
9. –shire by equal portions, and by making suit to the court of the lord bishop of Durham for us and for the heirs of our bodies legitimately procreated,
10. at Alverton from three weeks to three weeks In testimony of which matter with these writings
11. chirographs pertaining seals alternately are attached With these witnesses the Lord Robert of Colevyle, Robert of Conyers knights, John of Waxand, William Darele, Adam of Kyrkeby, John of Hamby, William of Foxton and others. Given at
12. Thornton in Strata on Friday on the morrow of the Assumption of the blessed Mary in the year of grace one thousand three hundred and eight.
